We often get questions such as, why are vitamins not covered? Doesn't it make sense to cover medical care that may prevent someone from getting ill in the first place? While we understand the reasoning, our answers to these questions are always directed to the laws that mandate the limitations of the medical coverage offered. The medical services that are covered under the various health insurance funds managed by SZV are established by the laws of the Government of Sint Maarten. These health insurance laws were established many years ago, with the focus to offer medical coverage for curative care. These laws do not make provisions for health prevention coverage. Simply said, your SZV medical insurance, in general, does not cover vitamins, birth control pills, vaccines, etc. Your SZV medical coverage pays the cost to cure and care. However, as your social & health insurance provider, we advocate and support many initiatives that stimulate low-cost access and knowledge of health prevention within the community. We are looking forward to meeting you at one of the community events!

# Medical coverage for stroke patients

Patients who are diagnosed with a stroke have several health care options available on Sint Maarten. Based on their condition, the specialist at the St. Maarten Medical Center will refer the patient to a local health care institution.

### The local health care institutions listed below offer specialized care for stroke patients:

- Rehabilitation Center at the White & Yellow Cross Foundation
- Enable Holistic Occupational Therapy
- Physical therapists on the island
- District Nursing via the White & Yellow Cross Foundation
- Medical Aids such as bed, wheelchair, brace, spalks etc.

The medical coverage for care at these institutions is covered through the AVBZ insurance fund. A stroke patient may also be in need of medical aids, this is also covered through the AVBZ insurance fund. An example of medical aid is home adjustment.

When a stroke patient undergoes rehabilitation, based on the condition of the patient, the occupational therapist or rehabilitation doctor may conclude that the patient is in need of a home adjustment. This request is submitted by the specialist to SZV for review and processing.

### What is a home adjustment?

Home adjustments are aimed at making the home of the patient accessible for daily activities.

- For example:
- Threshold removal in the shower
- Bedroom or bathroom door broadening
- Ramp to enter the home •

Home adjustment, is one of the examples of the type of medical aid that a stroke patient may need, which is covered by SZV insurance. For more information about AVBZ insurance visit www.szv.sx.



### **SENIORS & BENEFITS** CHECK

Apply for Old-age pension benefits 6 months before you reach your pension age

### Always inform SZV of;

LIST

- ✓ Change of name(s)
- Change of marital status
- Change of address
- Change of bank account number
- Change of telephone number
- Change of authorized representative
- Moving to another island or country
- ✓ Vacation: longer than 3 months

### Submit your documents on time;

- ✓ Life certificate
- School declarations
- **Application forms**
- Always make your own copies of documents for your administration



### **MEDICAL AUTHORIZATIONS**

A "machtiging" is an authorization letter issued by the SZV confirming that we will cover certain costs made by a ZV or OZR insured, person receiving AVBZ-care at a specialist. You can obtain a medical authorization for:

- · Paramedical care (speech therapist, dietician, psychologist, physical and occupational therapist)
- Prescriptions
- Regular use of medical aids ("hulpmiddelen")
- Regular use of prosthetics ("kunstmiddelen")
- Regular use of district nursing ("wijkverpleging") AVBZ
- Regular use of hearing aids AVBZ

Pensioners living abroad must send original life certificates ("Attestatie De Vita") on a regular basis. Failing to send your Life Certificate on time will result in blocking of pension payment until proof of life has been received by SZV. ### DID YOU KNOW SZV HAS A RADIO SHOW?




#### Me & SZV radio show co-host Charonne
