The AOV Pension Status Survey is in full swing. So far, the participation rate is about 55% of the 6.000 persons we are aiming to reach. The survey started in October of 2018 and will end on March 31st, it is for all persons receiving AOV pension who are registered as residing on Dutch Sint Maarten.

SZV has gone all out to ensure that all communication methods are being utilized to inform our pensioners. The support of our stakeholders and community members in doing so has been tremendous. It is great to see this type of teamwork extend itself beyond our office doors.

Would you believe that when asking our participants how they heard of the survey, the majority response would be via an online method? Our pensioners are going digital! The word-ofmouth is digital. #### **ONLINE APPOINTMENT REQUEST**



Did you know that SZV's #1 online service is the request for an appointment? This online service was introduced in 2016 and remains one of the top online services used by our customers. The popularity of the service is partly due to the fact that by going online to www.szv.sx, customers do not have to visit the office or call SZV to request an appointment, both options have a waiting time.

The option to request an appointment online was made available based on customer feedback. Customers regularly complained about long waiting times. SZV reviewed

these complaints and agreed that it is indeed a 'waste' of time to travel to the office and stand in line for a process that in reality could take less than 2 minutes. Having the option to request an appointment via the website makes it possible for the customer to do so literally, whenever they feel like.

"We receive requests at all hours or the day, Monday -Sunday. It is interesting to see at what hours people are reminded that they have to renew their insurance cards. We are delighted to be able to offer them this option, even after closing hours."

#### TIPS FROM OUR CUSTOMER SERVICE AGENTS

Tip

Always keep a record of important dates. Examples: medical procedures, visits to health care and service providers, submitted requests.

Tip 2

Always make note of contact persons. Examples: customer service representatives.

Tip 3

Try to make a copy of submitted documents/requests for your own records. Include the date submitted and the person or department it was submitted to.



If you receive documentation and do not understand the content, feel free to ask for clarity and assistance.



# START THE AOV APPLICATION PROCESS AT SZV ON TIME

We recommend six months before you reach the pensionable age. It does not matter if you are still working after you have reached the age of 62. You may still qualify for pension benefits from SZV if you are still working.

# 2019 Wage Limits & Premiums

The Director of the Social & Health Insurances St. Maarten (SZV) would like to inform the general public of the premium percentages and the new maximum wage limits. These new amounts will be effective as of January 1st, 2019.

Premium Percentages	Premiums (In percentages of income)
AOV 13%	Employer's contribution 7.00 % Employee's contribution 6.00 %
AWW 1%	Employer's contribution 0.50 % Employee's contribution 0.50 %
OV 0,5 – 5 %	The premium depends on the risk class your company is categorized in, and must be paid by the employer.
ZV 12,5 %	Employer contribution 8.3 % Employee contribution 4.2 %

Both the ZV (Sickness Insurance Ordinance) and the OV (Accident Insurance Ordinance) allow for yearly adjustment of the daily wage limits based on the consumer price index by means of a decree, containing general measures. Based on several factors, an indexation of the wage limits for the year 2019 will not be done.

#### Cessantia payment fls. 40,00 per employee per year

There will be no adjustment to the AOV/AWW amounts for 2019, due to the fact that the Department of Statistics (STAT) will not be publishing the consumer indexes (CPI) in 2018. The law mandates that the CPI of August be used in calculating and indexing the AOV/AWW amounts. As this calculation is not being performed, the amounts for AOV/AWW for 2019 will be the same as the amounts in 2018.
