IMPROVED RESPONSE TIME TO YOUR REOUESTS



Getting in contact with SZV about the status of your request is now easier. We've compiled the most frequently asked questions about individual cases and made it possible for you to ask us about your case via our website forms. this big news? By you making use of the website forms, our customer service agents can be sure that, we get the most important information about your case in order to assist you as quickly as possible. FACTS ABOUT YOUR GUT





- Your Gut hosts between 500 and 2000 species of micro-organisms (bacteria, yeast, parasites, viruses, etc)
- 60-80% of the immune system is located in the gut.

- Our microbes have 360 times more protein coding DNA than we do

BENEFITS OF PROBIOTICS AND PREBIOTICS


- Probiotics are micro-organisms that aid in digestion and provide additional health benefits
- Regulate local and systemic immune function, consequently decreasing inflammation
- Regulate bowel motility
- Support the mucosal barrier, supporting proper nutrient absorption
- Increase resistance to pathogens
- Produce essential B vitamins
- Prevent overgrowth of

- pathogenic bacteria, alleviating heartburn and bloating
- Prebiotics are non-digestible carbohydrates that serves as food for the probitoic bacteria
- Influence the composition of the gut bacteria
- Prevent GI and systemtic Infection
- Regulate appetite by regulating ghrelin and leptin
- Prevent cancerous changes
- Enhance nutrient utilization

TOP FOODS CONTAINING PREBIOTICS

- Raw chicory root: prebiotic content is about 65 percent of chicory root's total weight
- Raw Jerusalem artichoke: 32 percent of total weight
- Raw dandelion greens: 24 percent of total weight (also great for liver and kidney detoxification)
- Raw garlic: 18 percent of total weight
- Raw leeks: 12 percent of total weight
- Raw onions (including scallions):
 9 percent of total weight
- Cooked onion: 5 percent of total weight
- Asparagus: 5 percent of total weight
- Raw banana: 1 percent of total weight

MATERNITY LEAVE

Insured employees are entitled to a total of 12 weeks of maternity leave. You can choose between 4 or 6 weeks before estimated due date and the remainder after birth. You will receive control by the Control Doctor of SZV for 5 or 7 weeks after birth.

Who

ZV and OZR Insured.

Procedure

One (1) to two (2) weeks before the planned start of your maternity leave, you have to visit the SZV control doctor to sign-off for your maternity leave on your Yellow card of Blue card (in case you are an Government employee).

What to bring

- Your valid SZV Insurance card.
- If applicable, your Yellow card, if you are ZV insured.

- If applicable, your Blue card, if you are a Government employee and already have one.
- The signed letter from your gynecologist or midwife, indicating your due date.
- Please note:
- That your Yellow card is only valid when the Employer Information section is completely filled out and signed by your employer. This is only applicable for ZV insured.
- That your Yellow card must be signed by your gynecologist or midwife, or you will not be able to see the control doctor of SZV.

FAQ's

What to do if I am on sick leave before maternity leave?

You follow the regular AO-Control procedure.

SENIORS & BENEFITS – SPOUSE ALLOWANCE

Spouse Allowance

Spouses of pensioners who are under the age of 60 are entitled to an allowance if:

The couple's combined income is less then ANG 13,000 per year.

Who

Person younger than 60 years old who is married to someone who is already enjoying an old-age pension and who's combined income is less than ANG 13,000 per year.

Procedure

You need to come to the SZV office with all the correct paperwork to file an application.

What to bring

- Valid form of identification
- Submission of the combined annual income tax declaration (including proof of filing) of the previous year from the Tax Office
- Tax compliance declaration of youngerspouse who is applying
- Detailed registration form from the Civil Registry (not older than 3 months)
- Bank book or Bank statement
- Properly filled out Partner Allowance request form

Please note:

Once a spousal allowance is granted, the combined income tax declaration must be submitted yearly. The allowance will be temporarily halted for January of every year, awaiting the most recent income tax declaration.

PLAN YOUR VISIT TO SZV!



Plan your visit to SZV! We have 4 new service desks and on our website you can find exactly what you need to bring with you for each service! We understand the inconvenience of 'back-and-forth' and extended waiting times. With these new service desks we aim to reduce these hassles for our customers.

Find out which desks you have to go to the next time you visit SZV;

- Senior, Widow(er), Orphan; visit our Seniors & Benefits desk
- Employer; visit our Employers desk
- Employed or Insured as ZV, OZR or for Accident insurance; visit our Employees & Insured desk
- For doctor control visits, medical reimbursements, medical referrals, prescriptions or AVBZ; visit our Medical desk.

FAMILY MEMBER(S) REGISTRATION:

An ZV insured who is considered the breadwinner of the family can add the following co-dependents to his/her insurance:

- His/her legally registered spouse up and until the age of 59.
- His/her children up and until the age of 24.

"Children" meaning:

- · Minor legitimate children of the insured,
- Minor by law acknowledged children of the insured,
- Minor children of the insured born out of wedlock,
- Minor illegitimate children of the insured residing in the family home of the insured or whom the insured has to maintain pursuant to a court decision or an authentic (notarial) deed;
- Minor children related by marriage or foster children residing in the family home of the insured;
- Children who are considered adults by law but who are full time in school until they have reached the age of 25.

Please note:

SZV has to establish that you are insured under the ZV Insurance.

Only your legally registered spouse can be registered. No other family members, grandparent(s), boyfriends, or girlfriends can be added.

If you are working but your child has no valid residency permit, your child cannot be insured.
