

The Director of the Social & Health Insurances Sint Maarten (SZV) would like to inform the general public of the 2025 AOV/AWW amounts and the maximum wage limits. These amounts go into effect as of January 1, 2025.

The CPI of the second quarter of 2024 (CPI: 4.41%) has been used for the indexation of the amounts of AOV and AWW for 2025. Bear in mind that the AOV article 26 paragraphs 3-5 and AWW article 29 paragraphs 3-5 were not indexed 2022, 2023 and 2024 due to the negative consequences but are indexed for 2025. In accordance with the standard calculation method the fictitious figures of 2024 have been used to determine 2025.
